

Education

Well, it's hard to believe that we have finalized our educational symposia. Most likely you have received the program agenda and I hope that you have found it interesting. Jim Wood our Meetings and Conventions planner has really set up a wonderful venue; the Hyatt Pier 66. Your board was there for our summer board meeting and I must say that it is a wonderful hotel and the employees are very receptive to your needs. I spent some time over the years at this hotel, it's really changed and they appreciate our business. If you do claims work, the Florida Mariners Club is having their meeting at the same hotel the following week. Jim Wood really worked hard to get our meeting to coincide with the Mariners Club Meeting....Thank you Jim!

Our profession is undergoing tremendous changes in regards to ethics (conduct), technology and construction. Think about all of the changes in our industry in the last 5 years. A number of years ago (about 25) there weren't many changes in the business, it was stable and profitable and there was no need to make any progress in leaps and bounds. But then, something changed, new construction methods, new power plants, new wiring and most of all....electronics. How did we keep up with all these changes.... seminars, meetings and certification classes. You might ask..... why would our business have changed in the avenue of "ethics", wouldn't that be the same from day one till now. Yes your right, it hasn't changed, but "conduct" which in my opinion is part of ethics has changed. Our culture and generation gaps have made many changes in the way we do business, and your board and I reviewed a recent change from the American Society of Appraisers (ASA) in regard to conduct. While ASA doesn't set our standards, they are the recognized international society that sets the standards for the appraisal industry. Here is what your board and I have felt would be an addition to our "SAMS® Recommended Survey Standards".

"Prior to accepting an assignment, and if discovered at any time during the assignment, an appraiser must disclose to the client and in the report surveyor any services regarding the subject property performed by the appraiser within the prior three (3) years, as an appraiser or in any other capacity. This disclosure requirement will allow a prospective client to know, at the time of the assignment, whether the appraiser is performing, or has performed, other services with regard to the property, such as property

management, leasing, brokerage, auction, or investment advisory services, etc., thus allowing the client to determine potential conflicts, if any." There has been some discussion at regional meetings about "disclosure" of prior surveys. Your board and I feel that this conduct requirement will clarify the disclosure issue.

The education process in our industry has really changed as well. Seminars are offered every time you open a magazine or even when you open your email. ABYC has been a leader in the education process as well as IBEX, SAMS and NAMS. Our (SAMS[®]) educational meetings, both regional and international have been extremely well received in the maritime community. I personally have received many emails from some very prominent persons in the maritime industry about the positive educational content of our meetings.

One main subject that has really stood out and has been recognized at our meetings from people that are not surveyors, but maritime attorneys, insurance professionals and government personals is our ethics sessions. Many of you probably realize that I have included ethics in all of our meetings both international as well as regionally. Ethics is the backbone of any profession as well as conduct.

Joe Lobley our Executive VP and Stu McLea our Secretary/ Treasurer have a one hour program (I'm calling it the Joe and Stu hour) about ethics and conduct. If you attend this one hour seminar on Wednesday you will take a test and if you pass, it will be worth 5 CE credits. I'm sure that Joe and Stu will have a wonderful hour of fun and brainstorming. Come on down on Wednesday and receive an additional 5 CE credits!

Cargo

Overall confidence levels in the shipping industry are at their highest level since May 2008. A Shipping Confidence survey indicates that ship owners, managers, charterers and brokers all feel more confident than six months ago about the ship-

ping markets in which they operate, and more optimistic about making a major investment in the coming year.

The survey was conducted by Moore Stephens LLP, a member firm of Moore Stephens International Limited, a leading accounting and consulting group. The Moore Stephens Shipping Confidence Survey includes responses from key players worldwide in the international shipping industry.

"Our first-quarter 2010 was our worst in ten years, but in April we saw things start to pick up dramatically, partly because some cash-hungry companies started to unload non-core assets," noted one respondent. Other comments included, "We have passed the crisis point much sooner than anybody anticipated", and, "Despite all the economic and financial troubles, the demand for world trade will continue to benefit shipping".

The survey also revealed ongoing concern with regard to tonnage over-supply. "The overhang of new building orders has not yet been sorted out, and the market is likely to remain soft as a result," wrote one respondent. Another predicted, "Deliveries delayed in the second half of 2009 and the first half of 2010 will finally catch up on the market and result in an over-supply of tonnage." "With a loosening up of finance," said one respondent, "we can expect to see a major increase in mergers and acquisitions of weaker operators as the survivors of the recession look to improve their share of a smaller market".

So far as the markets are concerned, the renewed confidence evident in the previous survey that rates were likely to increase over the next twelve months was largely sustained. Owners and managers showed increased confidence that rates would rise in all three tonnage categories covered by the survey: tankers, dry cargo and container ships.

Moore Stephens shipping partner, Richard Greiner, says, "It is encouraging to note that, despite continuing general economic uncertainty worldwide, and irrespective of the further recent instability generated by the crisis in the Greek economy, confidence in shipping has now risen for the third consecutive quarter. There is an undeniable mood of renewed optimism in the industry. It is tempered by an underlying level of caution, but that is not a bad thing. Those who can remember bad markets are less likely to allow themselves to be caught up in further ones.

"Most people are expecting rates to go up in the tanker, dry cargo and container ship sectors. There are signs that banks might be willing to lend once more to shipping businesses that have done their homework and those which may have spotted new, viable opportunities in a shipping market which has changed significantly during the past two years. All this is good news for shipping. But with operating costs on a continual upward curve, companies and particularly those who are looking to expand would be well-advised to proceed with care."

Needless to say, an improvement in the overall shipping industry is good news for cargo surveyors. Although not as scientific as the above study, most cargo surveying colleagues that I have spoken with lately have stated that they have noticed an uptick in business over the last few months. We are cautiously optimistic that this trend will continue.

News from Standards Liason

H ello Worldly Marine Surveyors! The "Global Harmonization" process is as usual very much underway and will be ongoing and ongoing. You may not be aware of it but you are and have been inspecting vessels with many ISO Standards already in place and being used as guidelines.

There are new guidelines being formulated constantly as part of the truly monumental task of Harmonization. Regard for just a moment a vessel you may recently have inspected with fly by wire controls. Fairly regular these days although I doubt too many of us actually have test equipment in order to comment as to whether the equipment is actually doing what it should, the way it should. In this case you may wish to consult the ships papers and you will discover that this modern vessel answers to 40 plus ISO Standards as well as NMMA, ABYC with components listing SAE, UL etc. Now add to this mix ISO 25197-Concerning up and coming Electrical Steering. Someone, somewhere has to have a group of participants that can agree in several languages on numbers of subjects. They must agree that this part can connect to that part and that part can be tested with another part to ensure all parts do what they do as they should for a very long time and with the highest level of safety. It is quite easy to understand that it is probable for one standard to affect another thereby greatly complicating the finalization processes. The ABYC team is involved in exhaustive labors to bring this confusion to where

the technician, manufacturer, installer, builder and whomever has a hand in the creation maintenance or inspection has a standard from which to focus. Hopefully you have gazed upon items this very week such as gasoline fuel tanks where the world has come to some agreement where the ISO Standard is listed with SAE, ANSI etc in the ABYC Standards publication. We are inspecting to a Global Market even if we are not so aware as we might be. Will update on specific progress as we become aware of changes or update progress in different fields. Look for Green progress, tighter emissions, cleaners coatings and mandated builder procedures.

It is now understood that the Alliance of Marine Surveying Organizations may be introduced after some rocky starts in late December. Will continue to update as matters develop.

Have recently received an assignment for Euro type/CE inspection from an Adriatic Customer. The format required 84 photos in order to address all down flooding and safety issues and locations to satisfy the inspection criteria. The flooding calculations and port/perforation calculations are not difficult but do have at least in this format a specific order. A metric rule/ tape is a plus. Please be careful if you are performing inspections that you know will be for an export market.
